Cleaning Up the Country: Reforming the Waste Management Sector

Regulation in municipal solid waste management has recently undergone a major transition to a new model. Each region now has its own waste management plan and accompanying programme, and competitive processes were organized to select regional operators. These regional operators now serve as a one-stop shop for all matters related to waste disposal, closing illegal landfills, organizing sorting and recycling, and taking all remaining waste to disposal sites. Has the waste disposal industry become more effective and civilized? What challenges do regional and municipal governments face? What is the best way to start working with a regional operator, and how can the transition to the new regulation system be made with the minimum of disruption? Is it possible to attract investment in infrastructure? What needs to be done to ensure that every town and city in Russia – no matter what size – is clean, green, and pleasant to live in?

Income from Waste: Making the Industry Attractive to Investors

Russia began to reform its household waste processing sector on 1 January 2019, with the aim of reducing the number of landfills, and making the market transparent and civilized. The Ecology national project sets out two key targets for this reform: increasing the percentage of processed waste from 12% to 60%, and recycled waste from 7% to 36% by 2024. In order to achieve this, there needs to be an overhaul of the way the waste management sector is financed. Public funds alone will not be sufficient to change the system – private investment is also needed. Preliminary estimates put the amount of investment needed at RUB 200–300 million. Long-term tariffs will be examined as a way of attracting this investment.

OECD Standards on Responsible Conduct for Development Institutions

Today development institutions play a significant role in the global economy and international development. Projects of development institutions are exposed to traditional financial risks and non-financial risks associated with social, environmental aspects. Meanwhile, projects with embedded standards of responsible business conduct (RBC) are less likely to bring "surprises" for the investor. Responsible project financing is not only a factor in reducing costs but also a factor of investment attractiveness. The investment portfolio where there are demands for responsible behavior shows a return of 16.8% higher than the average global fund returns (MSCI World Index). At the session, the participants will discuss the current approach of different development institutions to RBC standards and possible ways to harmonize it and make it more efficient. Objectives of the event:

- 1. To determine the effectiveness of responsible business conduct standards for VEB and other development institutions. How they make an impact on the sustainability of projects, investment attraction, export.
